

1. What is ProfitMAX?

ProfitMAX is a reseller program with a comprehensive system of tiered support services that reward you for your loyalty. ProfitMAX has very specific goals, foremost of which is to add value to your business by improving your margins and providing the best support available in the security industry.

2. Who should enroll in ProfitMAX?

If you are a reseller, dealer, or systems integrator who sells Toshiba video surveillance or competitive products, and/or has network systems expertise, or provide solutions that are compatible with Toshiba products, and you are seeking to resell reliable surveillance solutions, then you qualify as a ProfitMAX Reseller.

3. Why should I enroll my company in the Toshiba ProfitMAX program?

In addition to valuable rebates based on dollar volumes, as a ProfitMAX reseller you are offered exclusive programs to help you increase your profitability and sell more Toshiba products.

4. What will Toshiba do with the information that I provide in my application form?

Your application profile information will in no way be sold to any third party. Your information will only be shared between Toshiba, its territory sales representatives and qualified distribution partners.

5. Is there a fee associated with the ProfitMAX program?

There is no fee to join ProfitMAX. We consider the opportunity to earn your increase in business a nominal fee.

6. Is there a commitment to join the ProfitMAX program?

There is no commitment to join ProfitMAX, however in order to maintain your tiered level you will need to meet the minimum required 6 month period sales volume.

7. What are the benefits of being in the Toshiba ProfitMAX program?

9. Why can I only pick two (2) distributors to partner with under the program?

ProfitMAX resellers will be paid margin building rebates from up to two qualified distribution partners.

10. How will rebates be paid and when?

Quarterly rebates will be calculated by Toshiba and dispersed within 60 days after the end of the calendar quarter. Rebates will be issued directly to the Reseller in the form of a check. For more information, review our [Terms and Conditions document](#).

11. Will I get paid a rebate from both of my chosen distribution partners?

Yes. Rebates will be calculated from each distributor.

12. What are the different partner levels associated with ProfitMAX?

ProfitMAX is a system of tiered support services. All resellers start at Silver, and move to Gold, Platinum or PlatinumPlus based upon their 6 month period sales volume with Toshiba.

13. What is the minimum sales requirement to become a ProfitMAX dealer?

There is no initial minimum requirement; however after one year from signup all resellers but meet Silver level membership requirements.

14. What are the sales volume requirements to be a Silver, Gold, Platinum and PlatinumPlus ProfitMAX reseller?

Six month sales volume (April - September) (October - March) for:
Silver is \$1-49,999
Gold is \$50,000 – 99,999
Platinum is \$100,000 – 199,999
PlatinumPlus is \$200,000+

15. Once I meet requirements and move to a higher tier level, how long will I stay at that level?

ProfitMAX resellers will stay at that level for the following 6 month period. For example, if you purchased \$52,000 (reached Gold status) during the period of April - September, your company will reap the benefits of Gold status for October – March.

16. What type of sales and marketing support is offered to ProfitMAX dealers?

As a ProfitMAX reseller, you'll have direct immediate access to our experienced pre- and post-sales support representatives to assist you in specifying and selling Toshiba security products.
